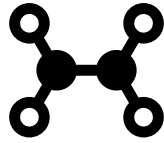

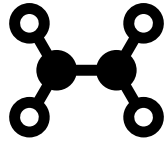


MESSAGE FROM THE CHAIRMAN


LIGHTHOUSE FORWARDER (UPCOMING)
